Conversion from B1 (offices) to C3 (3 flats)

Conversion of one three storey dwelling and rear extension into 4 apartments with associated parking, cycle storage and bin storage.

Works to trees subject to a Tree Preservation Order: Lime tree remove epicormic growth.

Works to trees subject to a Tree Preservation Order, Holly Tree raise over drive to allow more light in property.
- 3. CB/ENQ19/00111** **40 WATERLOO ROAD, LINSLADE**
Works to trees in conservation area, London Plane Crown reduce to 30%. Willow – crown lift to 2.4 metres to prevent obstruction of footpath and highway.
- 4. CB/TRE/19/00101** **CLAREMONT HOUSE, LOVENT DRIVE**
Works to a tree protected by a preservation order prune sycamore tree .
- 5. CB/TRE/19/00095** **1A LEOPOLD ROAD, LINSLADE**
Works to trees subject to a Tree Preservation Order, remove epicormics growth from within the Crown, raise over road to 5 metres and clear branches from phone line, to allow more light and clear road for high vehicles.

Works to trees protected by a Preservation Order: Prune one Oak, one Cypress and one Cedar tree to the front of the property and one Oak to the rear of the property.
