### **Draft Milton Keynes East Development Framework Supplementary Planning Document**

Milton Keynes Council is making available the Draft Milton Keynes East Development Framework Supplementary Planning Document for consultation and inviting comments from members of the public, organisations and other stakeholders.

The consultation will commence on **7 August 2019** and comments must be received no later than **5.00pm on 16 October 2019**.

The Milton Keynes East Development Framework Supplementary Planning Document will guide future applications for development within the Milton Keynes East Strategic Urban Extension which has been allocated in Plan:MK 2016-2031. The allocation covers approximately 440 hectares of land encompassed by the M1 to the west, the A422/A509 to the north, and Moulsoe and the wider rural area to the east.

The SPD will support policies in Plan:MK and will be considered a material consideration in the determination of planning applications submitted to the Council.
